# **QUESTIONS, CLARIFICATIONS, RESPONSES & ATTACHMENT(S)**

On page 23, IV. A., under scope of services it is stated that "Contractor will provide 100% *full coverage* 24/7 labor when necessary and material including replacement parts, equipment, tools, supervision, transportation etc.

# Question#1:

Regarding the term "Full Coverage", is that describing The 24/7 labor necessary to replace parts, equipment tools, supervision etc. or does it also include equipment replacement (entire condenser, air handler or AC unit) is to be covered?

TSA Response: It does not include the complete replacement of the equipment (Units).

In our (Krauss Company) vernacular, "Full Coverage" is a level of maintenance that includes replacement of entire units or systems if they cannot be economically repaired. Full Coverage, is our premium and most expensive level of service that puts the entire financial responsibility of service, repair, supplies and/or replacement equipment if necessary, on us.

TSA response to above statement: Full Coverage is the repair or component replacement which would include the necessary parts, supplies, materials and service required to get the covered piece of equipment operational. All changeable or serviceable parts and components should be considered to be covered under "Full Coverage".

#### **Question #2:**

In the same paragraph, it states that the equipment listed in Schedule 1 "Equipment List" is what is to be covered for maintenance and repair. Schedule 1 is comprised of only 22 pieces of equipment. Are these 22 pieces the only that will be included under the maintenance program and the other 7 pages of equipment under Bid form 3 of 3 will have filter changes only?

<u>TSA Response</u>: That is correct, the only service being requested / priced under bid form 3 of 3 is filter changes only.

Under Schedule 1 Equipment list, is the reference "installed 8/24/17" a typo?

**TSA Response:** This was a typo and the date installed originally written as 8/24/17 should reflect 8/24/2016.
