ADDENDUM TO: Cart Barn Construction, Rogers Park Golf Course

TO BIDDER: This addendum is an integral part of the Bid file under consideration by you as a bidder in connection with the subject matter identified above. For the purpose of clarification, the following additions, changes, modifications and replacements noted below have been made to the Bid and have been

made to the Bid file which bears the above title.

Bids submitted shall conform to these additions and modifications noted herein and including all issued addendums.

1. Replace the Bid Proposal Page (19) with the New/Revised Page 19

QUESTIONS AND RESPONSES:

- 1. Several contractors noted that most of the sheathing will have to be replaced. Do you agree? Yes, but to what extent is up to you and the contractors. The sheathing is just a cover and not a part of the structural system.
- 2. How long should this job take? This will probably vary by contractor. We would anticipate the project could take anywhere from 2-6 months depending on the experience and staffing availability of a given contractor.
- 3. MBE/SBE Preference: No
- 4. 25% of work shall be contract awardee performed.
- 5. Budget is \$65K
- 6. Is there an allowance for building sheathing? Specifications attached
- 7. Do we have a plan for the prevention of future corrosion? Yes

- 8. Expected start and completion dates. This project should conclude no more than 90 days after the contract execution.
- 9. Will the Authority take into consideration any additional work suggested by Contractor? Yes
- 10. Liquidated Damages Standard boilerplate language
- 11. What happens to all items inside of the building during construction? Who is responsible for securing the property & how will property be secured? TSA will take responsibility for the golf course property. The contractor will be responsible for its own property.
- 12. Will the outside sheathing be replaced? Specifications attached

In your bid, provide an alternate for metal sheathing, based on a per panel price.

There are approximately ninety (90) metal sheaths on the Rogers Park Cart Building. Of which approximately twenty-four (24) need to be replaced.

They are to be replaced with 26-gauge panels 114" x 36"

If there are more than (24) panels that need to be replaced, the contractor and owner will agree before any additional panels will be replaced.
