TO PROPOSER: This addendum is an integral part of the Bid file under consideration by you as a bidder in connection with the subject matter identified above. For clarification, the following additions, changes, modifications, and replacements noted below have been made to the Bid and have been made to the Bid file which bears the above title. Bid proposals submitted shall conform to these additions and modifications noted herein and include all issued addendums.

QUESTIONS AND TSA RESPONSES

Question #1 – Regarding the 250 FSIC Core Padlocks - The part number on the price sheet doesn't include a core should a core be included in the price and if so do you have a part number?

Yes, a core should be included in the price and the part number is 23-030.

Question #2 – Regarding the FSIC Core cable locks; part number was not listed?

Allegion has given us the following part number 999253 for the cable locks and then we should add 30 of the KS43F3200 and 30 of the 23-030 to make the cable system complete as the original FSIC cable locks are no longer being produced.

Question #3 – Regarding the FSIC Door Handles; part number was not listed? The Questions was asked about the FSIC Door Handles, the part number was not listed?

Allegion has given us the part number of ALX53-J-TLR-626 for the door handle and then a matching quantity of the 23-030 FSIC for the handles.

Question #4 - *Request for Clarification* regarding the 2,500 Restricted cut keys and the part number being incorrect part number? *Allegion has corrected the part number to be 48-268 which is a correction from the initial price sheet.*

Note from TSA: The Project Manager has confirmed again with the Allegion/Schlage Rep regarding all Allegion/Schlage part numbers listed in the bid document and have been told they are correct.

Question #5 - Is the morse system only delivered? No unboxing, setup, installation, training necessary? *Yes, only delivered.*

Question #6 - Is the triton plus system only delivered? No unboxing, setup, installation, training necessary? *Yes, only delivered.*

Question #7 - Is the Schlage sitemaster system only delivered? No unboxing, setup, installation, training necessary? *Yes, only delivered.*

Question #8 - Do you have a master key schedule showing what bitting is to what core and for what door, for the following line-item materials: **As discussed in the pre-bid conference the answer is No. This will not be given until the project is awarded.**

Question #10 - Do you have a part number for cable locks? **Yes, see updated price sheet (attached)**

Question #11 - When will we get the master schedule? **See above. After the award.**

Question #12 - Does my Miami-Dade County license substitute for Hillsborough County locksmith license requirements? **You must be licensed in Hillsborough County. See link below.**
