Bids submitted shall conform to these additions and modifications noted herein and including all issued addendums.

QUESTIONS & RESPONSES

Question: Item number 2 and item number 3 are items that are product specific and manufactured by PPG. It is my understanding that on a public bid, specific item brands cannot be solely required as a bid item as long as there are comparable products available, Sherwin Williams makes several cross over products. Will it be acceptable to submit the Sherwin Williams equivalent?

TSA Response: A public agency is allowed to bid “brand specific”. TSA has used your company’s “product equal” and found the Sherwin Williams product does not bond as well as the PPG brand product. TSA would be willing to “Product Test” your product again if you are willing to submit samples at the time of your bid submittal. Your product(s) must meet specifications or be “equal to” and colors must match and be approved by Authority staff.

Question: Solvent Based Dry-Fall Semi-Gloss; is this interior?

TSA Response: Exterior.

Question: Pitt-Tech Gloss Series 90-374; This product is a high gloss, Interior/Exterior DTM. Is that what you want?

Question: Pitt-Tech Gloss Series 90-812; This product is a semi-gloss, Interior/Exterior Dry-Fall. Is that what you want?
