As we flip to the second page of the drawings, this identifies the Vomitories at the lower seating bowl.

So there's a combination of the Vomitories and the accelerated aisle stairs that go up.

Each of those are circled and highlighted and and refer to and large plan.

It's both on the east and West sidelines of the stadium was where these occur.

The glaze decorative metal railing specification calls out the performance requirements.
