ADDENDUM TWO to Bid #17-08

Fabrication of Replacement HDPE Plastic Stadium Seat Backs Raymond James Stadium

- 1. The bid form has been revised to clarify the breakdown of the quantities. Revised form attached.
- The bid opening has been changed to July 17, 2018 at 10:00. Please submit the bids electronically by FAX per the following instructions:
 - You must <u>Fax</u> your Bid Proposal <u>Pages #BF-3</u>, <u>BF-4 AND BF-5</u> to fax number <u>813-350-6611</u> not later than 10am on Tuesday, July 17, 2018. Please include a cover sheet with <u>your name and company name</u> listed. All other documents (bid forms, etc. listed under Bid Package Assembly on the cover of the bid form) should be emailed to <u>djones@tampasportsauthority.com</u> not later than 10am on Tuesday, July 17, 2018.
- 3. Bid security in the form of a bond or cashier's check is required per the bid documents. Include a copy of the bond or check with your bid and mail the hard copy via certified mail or some other secure form such as Fed Ex. Address to the attention of Deltecia Jones at the Tampa Sports Authority. The address may be found on the cover sheet of the Bid Documents.
- 4. It is acknowledged that most seat backs will be 19 inches in width. For purposes of this bid the unit price presented will be the same regardless of seat back size. This also pertains to the price of the mold.
- 5. The following questions were received. Answers provided after each question.

Bidder One:

- 1.) Are bids to included or exclude tax? Exclude tax
- 2.) Is a contractor's license required as specified or just to be registered to do business in the State of Florida? Just be registered to do business in Florida
- 3.) If we cannot meet the requested dates can an alternate schedule be provided? We are flexible on schedule; however time is of the essence. Schedule will not necessarily be a deciding factor in acceptance of bid
- 4.) If we are to provide labor to install seat back can labor be open shop meaning no prevailing wage rates or union labor? Florida is an Open Shop state
- 5.) If we install new seats backs are we to remove the existing seat backs and dispose of those backs? Per Alternate #2 (see detailed spec) Labor to Replace Chair Backs: Provide a complete replacement of the chair backs including (but not limited to) the following: 1. Removal and disposal of the existing backs, hardware, and associated product/materials. 2. Installation of new backs, hardware, and any other associated product/materials.

- 6.) All designs and tooling to make our seats including the molds are property of Hussey Seating as we have sizable expenses and investments in product develop. We consider the Olympiad design, tooling and molds to be propitiatory information and will not turn over the molds as requested. Will you still consider a bid from Hussey Seating without us turning over our propitiatory molds. The bid allows for OEM as well as aftermarket product for the replacement Olympiad model chair backs. A bid without ownership of tooling/molds for the TSA will be acceptable. Please ensure that your bid proposal clearly identifies that tooling/molds will or will not be provided to the TSA -
- 7.) Your warranty request does not include a measurable level of fade that is referred to as a Delta E. Please provide this for your requested warranty and if we cannot meet your request can we still bid but detail what level of fade we will warranty to? Delta should not be greater than 5 as measured within CIE L*a*b color space. Specification is based on OEM product from Hussey Seating Company's outdoor seating warranty. Any deviation to this requirements must be clearly noted as a qualification/exception on the bid proposal
- 8.) Your warranty request "to protect the seats from failure of making the seats unattractive". Please define what this is or considering delete the word "unattractive" as this is subjective to interpretation. Unattractive shall be defined as cracking, crazing, fading, or other visual deterioration within the warranty period -
- 9.) If we have a new seat back product that will fit onto the Olympiad stanchion can we also provide an alternate for this option? We would be willing to send several samples for you to install into the stadium for review and consideration. The bid is specifically for replacement Hussey Olympiad style backs. A different style/model can be bid as an alternate and may be considered by the TSA based on fit, appearance, and potential cost savings
- 10.) Are seat numbers that are integral to the back of the seats to be provided? It is expected to be much less expensive to produce the seat number labels and labor as a separate bid. It would be acceptable for bidders to provide a voluntary ADD for seat number and labor to install them. The seat number style should match the existing rectangular lexan adhesive plates.
- 11.) Does the installation include removing the existing cupholders if already attached to the seats and reinstalling them? YES Is cupholder hardware to be replaced or reused. Yes, Installation of the replacement chair backs should leave the facility in the same or better condition than before the work is performed. The successful bidder will be responsible to remove and reinstall and cup holders present on the seating prior to commencing work. A list of any broken, damaged, or missing cupholders shall be provided to the TSA who will be responsible for replacement cup holder product(s)
- 12.) Do you want the testing information described for the seat backs included with the proposals? YES

Bidder two:

- 1. Will the seat numbers be re-used? It is expected to be much less expensive to produce the seat number labels and labor as a separate bid. It would be acceptable for bidders to provide a voluntary ADD for seat number and labor to install them. The seat number style should match the existing rectangular lexan adhesive plates.
- 2. Are there cup holders installed on the backs of the seats? If so, will there need to be a longer bolt to accommodate them? Please identify specifications for hardware. Yes, Installation of the replacement chair backs should leave the facility in the same or better condition than before the work is performed. The successful bidder will be responsible to remove and reinstall any cup holders present on the seating prior to commencing work. Due to the variation on cup holder attachment design and the unknown tolerance / variance of the new backs, the TSA can not specify the exact size for any required hardware. The OEM specification for back attachment with cupholders specifies: "MS 1/4 x 2" PTH SS (back hardware for cupholders". The exact hardware length requires should be verified by each bidder to

confirm with the product they are proposing. A list of any broken, damaged, or missing cupholders shall be provided to the TSA who will be responsible for replacement cup holder product(s)

- 3. Add Alternate 1 is for the pricing of new <u>stainless-steel</u> hardware. This number will vary greatly depending on the quantity if seat backs ordered. Is there a quantity in the base bid that you would like us to use to quote the hardware? The quantity of hardware will vary based on the quantity of backs. Hardware should be priced per back at the same quantities as backs
- 4. With the varying quantities in the base bid, will you accept a minimum run quantity for each seat size? If there is a minimum run size or set-up fee for less than a specific quantity of any part, the bid should qualify that and clearly explain the cost(s).
- 5. Would <u>aluminum hardware</u> be an acceptable replacement for stainless steel? The specification is for OEM replacement which includes stainless steel hardware. Aluminum hardware may be proposed as a voluntary alternate if there is a notable cost savings to the facility
- 6. Due to the nature of varying seat sizes and not knowing exact quantities of each needed, are you okay with us providing a pricing matrix without the total price? For example, for the Unit Price for a quantity of 5,000 you will receive an each cost for 19", 20" & a 21" seat back. Once you determine how many of each you size you will need you can total the price accordingly. Refer to the answer for #4. We would like to keep the pricing consistent and handle and lot size requirements as an exception.
- 7. Has the Tampa Sports Authority reviewed if there are any patent issues with producing a seat that is a replacement to the existing Hussey seat? No records have been found on the Hussey Seating Olympiad product regarding patents. The Olympiad Chair design is greater than 20 years old and had any undiscovered patent been issued, it would be well past the 20 year expiration date from filing and 17 year date from grant.
